**TRUCK FREIGHT:** If the item to be ordered is too large for **UPS**, it must be shipped by common carrier (Truck Freight). Items that must be shipped via truck, may be shipped "**FREIGHT COLLECT**" or "**PREPAID**" call for quote details.

**RETURNS & EXCHANGES:** Merchandise that we offer is warranted against defects in materials and workmanship if notified within **15 days of receipt** by the customer. Liability of Gold Eagle Classics (GEC) is limited to the replacement of the defective part only. If you are unsatisfied with a product purchased from GEC and would like a Refund, we ask that you do so within 15 days of receipt. **No Refunds after 15 days.** Returns after 15 days will be for **Exchange** or **In-Store Credit** only. All returns are subject to a **20% Restocking Fee**, Inspection and/or the following conditions:

- **No returns after 30 days.**
- Each product returned must be in its **Original, Unused Condition and Packaging.**
- Products being returned by **US Mail, UPS, Fed-Ex** or any other carrier must be **Pre-Authorized** first by GEC with a **Return Authorization Number (RA #)** and accompanied by the **Original GEC Invoice** or they will **Not** be accepted.
